ORDINANCE NO. 187673

*Amend Intergovernmental Agreement with Multnomah County for additional County funds in the amount of \$32,500 for an emergency shelter for homeless veterans (Ordinance; amend Contract No. 30002899)

The City of Portland ordains:

SECTION 1. The Council finds:

- 1. Ordinances No. 185864, 186369, 186499, 186925 and 187365 authorized prior amendments to an Intergovernmental Agreement (IGA) No. 30002899 between the Multnomah County Department of County Human Services (County) and the City of Portland, Portland Housing Bureau (City) to provide a total of \$769,590 in County general funds for flexible outreach and housing placement to veterans and people experiencing homelessness in incorporated and unincorporated areas of Multnomah County east of the Portland city limits (East County).
- 2. On October 7, 2015 City Council passed Ordinance #187370 declaring a housing emergency.
- 3. The County has initiated an additional amendment (Exhibit A) to the existing IGA to add \$32,500 in County general funds and to extend the scope of the IGA to address the housing emergency through shared funding of an emergency shelter for veterans experiencing homelessness. That shelter began operation in October 2015, under Subrecipient Contract #32001277 between the City and Do Good Multnomah.

NOW, THEREFORE, the Council directs:

- a. The Bureau Director and the City Auditor are authorized to execute Amendment No. 6 to the Intergovernmental Agreement between the City and the County, attached as Exhibit A.
- b. The Mayor is hereby authorized to accept on behalf of the City payments of up to \$802,090 from the County as specified in the amended IGA.
- c. The Portland Housing Bureau is authorized to perform all administrative matters in relation to the IGA, requests for reimbursement from the County, and to submit required reporting on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because the associated revenue is required to address emergency shelter needs associated with the housing state of emergency within the current fiscal year. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.
