ORDINANCE No. 105757

An Ordinance granting a revocable permit to American Bitumuls & Asphalt Company, a Delaware corporation, on application by G.L. Ritter, District Manager, to increase bulk storage facilities at their Willbridge Refinery, located on St. Helens Road, subject to certain conditions, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. The Council finds that American Bitumuls & Asphalt Company, a Delaware corporation, by G.L. Ritter, District Manager, applied for permission to increase bulk storage facilities by constructing an additional above-ground oil storage tank having a capacity of 135,000 barrels, in accordance with the application of said corporation dated March 19, 1957, and the plans and specifications submitted with said application, together with an outline on said map of the property on which the additional installation is to be located, all of which are attached to Council Calendars No. 1331 and 1587 (1957) which by this reference are made a part of this ordinance; that the Buildings Inspection Director has recommended that this permit be granted according to the recommendations and conditions of the Fire Marshal; that the report of the Fire Marshal recommends that the permit be granted subject to certain conditions, only the following of which are hereby made conditions to the granting of said permit:

1. That fire wall, tank foundation and pipe support details, as shown by attached drawings, first be checked and approved by the Bureau of Buildings.
2. That all new piping shall conform with ASTM specifications A-53 for seamless steel piping, and that the valves shall be of steel in accordance with the company letter to the City Council.
3. That the new tank shall be constructed to API specifications 12-C with the API monogram attached upon completion.
4. That tank and fire wall construction shall be under permit of the Bureau of Buildings, as provided for by Sec. 14-1414 (b) and 14-1415 (c) of the Fire Code.


now, therefore, a revocable permit hereby is granted to the American Bitumuls & Asphalt Company, a Delaware corporation, subject to the above enumerated conditions, to construct and maintain one additional above-ground oil storage tank, having


a capacity of 135,000 barrels, in accordance with the application for permit and plans submitted by said company, and attached to Calendars No. 1331 and 1589, the same to be constructed and maintained on property more particularly outlined on said map; said construction and maintenance of said tank to be made in strict compliance with all ordinances and codes of the City of Portland relating thereto. Nothing contained herein shall be taken or deemed to exempt the company from all applicable provisions of the Fire Code of the City of Portland nor from other ordinances of the City; nor shall anything contained herein be taken or deemed to create any vested or property right and no expenditure of money, lapse of time, or any act or thing shall prevent the Council of the City from at any time revoking this permit. No action shall be taken hereunder until a suitable document approved as to form by the City Attorney shall have been signed and filed with the Auditor by said corporation, accepting and agreeing to the terms, provisions and conditions hereof.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: That the need in the City for additional facilities for storage and distribution of petroleum products is such that there should be no unnecessary delay in the proposed increase of such facilities; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
