ORDINANCE No. 106603

An Ordinance to amend Section 3 of Ordinance No. 95575, relating to the vacation of N. W. 8th Avenue from the south line of N. W. Hoyt Street to the north line of N. W. Glisan Street.

The City of Portland does ordain as follows:

Section 1. The Council finds that over a period of six years there has been controversy and negotiation between the City and the Federal Government with reference to the conditions imposed in connection with the vacation of N. W. 8th Avenue between N. W. Hoyt and N. W. Glisan Streets; that in lieu of condemnation suit by the Federal Government, it is in the public interest that certain conditions be eliminated and others modified, which can be done without jeopardizing the City's position, particularly in light of the removal of utilities from N. W. 8th Avenue in the area involved; now, therefore, Section 3 of Ordinance No. 95575, entitled "An Ordinance vacating N. W. 8th Avenue from the south line of N. W. Hoyt Street to the north line of N. W. Glisan Street, initiated by the Council of the City of Portland", passed by the Council December 19, 1951, hereby is amended to read as follows:

Section 3. This vacation hereby is made contingent upon the following conditions:

- (a) The Auditor shall file for record with the County Clerk, who is ex-officio recorder in and for Multnomah County, State of Oregon, a certified copy of this ordinance and likewise file copies with the County Assessor and the County Surveyor of said County.
- (b) The construction and reconstruction of sidewalks, curbs and driveways shall be at the sole cost and expense of the United States Government as owners of the property and shall be made in accordance with plans and specifications approved by the City Engineer of the City of Portland, Oregon. The sidewalks, curbs and driveways to be constructed or reconstructed by the government as a condition to the vacation are those at either end of said parcel which will be required for continuous sidewalks and curbs along N. W. Hoyt and N. W. Glisan Streets and shall not include or require any gutter construction in connection therewith.
