An Ordinance accepting two deeds to the same property from Halline Equipment Company and Emilio Rivelli and wife, for the widening and extension of S.E. Reedway Street at S.E. 26th Avenue, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. That the following described parcel of properby be and is hereby accepted for street purposes:

A tract of land in Section 13, T. 1 S., R. 1 E., W.M., and more fully described as follows:

Commencing at a stone monument marked "H.K." on top, which is set for a point 47.65 chains South and 4.12 chains East of the Northwest corner of Section 13, T. 1 S., R. 1 E., of the Willamette Meridian, which point is the Southwest corner of a certain tract conveyed by L. J.
