Attendance of David Duvall at the national meeting of the USCA in New York City

Dear Commissioner Bean:

David Duvall, the Golf Director and manager of all the municipal golf enterprises of the Bureau of Parks, is the United States Golf Association representative for Oregon and as such is the representative of all amateur public links golfers in the state.

He has recently been notified by the Executive Director of the U.S.G.A. that the president has appointed him to the Public Links Committee of the national organization for the current year.

Mr. Robert Dwyer of Dwyer Lumber Company and Waverly Golf Club is a director of the U.S.G.A. and one of the only two directors from the west coast, the other being from Orinda, California. He suggests that it would be in the public interest to authorize Mr. Duvall to attend the national meeting in New York City on January 26 and 27, and, at the same visit, to inspect management and facilities of some typical golf installations in that metropolitan area.

Your Superintendent of Parks concurs and suggests that Mr. Duvall be authorized to attend the meeting and make such inspections, and that \$400 be transferred within the Golf Fund from 6102.430 to 6101.310 for that purpose.

ORDINANCE NO. 114610

An Ordinance authorizing and directing David Duvall, Golf Director in the Bureau of Parks, to attend the United States Golf Association national meeting in New York City, January 26 and 27, 1962, granting a leave of absence with pay, making a transfer of appropriation within the Golf Fund, authorizing the drawing of a warrant in the amount of \$400.00, providing for an accounting and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. The Council finds that the United States Golf Association will hold an annual meeting in New York City, January 26 and 27, 1962; that David Duvall, Golf Director and manager of all municipal golf enterprises of the Bureau of Parks, is the United States Golf Association's representative for Oregon and the representative of all amateur public link golfers in the state; that he has recently been appointed by the president of the United States Golf Association to the public links committee of the national organization for the current year; that Mr. Duvall has the approval of the Superintendent of Parks to attend the national meeting in New York City and at the same time to inspect the management and facilities of some typical golf installations in that metropolitan area and that it is in the best interests of and of considerable value to the City of Portland to have David Duvall attend the forementioned meeting and make the inspection of various golf installations in the New York City area: now. therefore, David Duvall, Golf Director in the Bureau of Parks, is hereby authorized and directed to attend the United States Golf Association's national meeting in New York City, January 26 and 27, 1962, and to make an inspection of the management and facilities of typical golf installations in that metro-politan area, and leave of absence with pay is hereby granted together with the necessary travel time.

Section 2. In order to provide funds for the above authorized trip, the sum of \$400.00 is hereby transferred within the Golf Fund from the appropriation Rose City Golf Course, Equipment Repairs, Code No. 6102.430, to Eastmoreland Golf Course, Travel and Transportation, Code No. 6101.310. The Mayor and the Auditor are hereby authorized to draw a warrant in the amount of \$400.00 in favor of David Duvall, Golf Director in the Bureau of Parks, chargeable to the said appropriation. It is hereby specifically provided that David Duvall shall file with the Auditor a statement together with such vouchers as are obtainable showing cost of transportation, hotels, meals, etc., and any remaining balance shall be returned to the Golf Fund and placed to the credit of the appropriation on which the warrant was drawn.

ORDINANCE No.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that David Duvall may make the arrangements for the trip authorized in Section 1. above without delay; therefore, an emergency is hereby declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.
