ORDINANCE No. 118615

An Ordinance amending Ordinance No. 117519 in order to permit the purchase of two punch-type validating machines without a written contract for the Municipal Court at a cost not to exceed \$9800, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that Ordinance No. 117519, passed by the Council October 10, 1963 authorized and directed the Purchasing Agent to purchase on the open market without calling for bids at a maximum cost of \$9800, two punch-type validating machines for the Municipal Court; said purchase was to be made in accordance with a written contract to be entered into by and between the City of Portland, acting by and through its Mayor as Commissioner of Public Safety, and its Auditor, and the National Cash Register Company; that a written contract was never executed as required by said Ordinance No. 117519; that, however, the Purchasing Agent by purchase order No. 32528, dated October 14, 1963, directed the National Cash Register Company to deliver said validating machine; that pursuant to said purchase order the validating machines were delivered to the Municipal Court; that Ordinance No. 117519 should be amended to authorize the purchase of said validating machines by purchase order rather than under a written contract; now, therefore, Ordinance No. 117519, passed by the Council October 10, 1963, hereby is amended to authorize and direct the Purchasing Agent to purchase on the open market without calling for bids at a maximum cost of \$9800, two punch-type validating machines for the Municipal Court by purchase order rather than pursuant to the terms of a written contract; all the other terms and provisions of Ordinance No. 117519 shall remain the same.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that the purchase of and payment for the aforementioned validating machines may be made without unnecessary delay; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
