## ORDINANCE No. 120036

An Ordinance authorizing the purchase of one long reach stapler (not budgeted) for the Bureau of Design at an estimated cost of \$25.00, authorizing the drawing of a warrant making a transfer of funds, and declaring an emergency.

The City of Portland ordains:

Section 1. It appearing to the Council that the Bureau of Design is in need of one long reach stapler and that the purchase of this equipment is not authorized in the current budget; now, therefore, the purchase of one long reach stapler for the Bureau of Design is hereby authorized at an estimated cost of \$25.00, the said purchase to be chargeable to the General Fund Appropriation, Bureau of Design, Equipment, Code No. 2950.720, and the Mayor and the Auditor are hereby authorized to draw and deliver a warrant on the said appropriation in payment for the said equipment when a demand therefor approved by proper authority is presented.

Section 2. The sum of \$25.00 is hereby transferred from the Budget Contingencies Account No. 3830 to the General Fund Appropriation, Bureau of Design, Equipment, Code No. 2950.720.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that the purchase of the said equipment may be authorized without undue delay; therefore, an emergency hereby is declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.
