

## ORDINANCE NO. 121333

An Ordinance granting authority to the Bureau of Water Works to locate, construct and maintain a pump station upon Park Bureau property North of West Burnside Road, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that in order to supply the newly constructed Pittock Reservoir westerly of the Pittock residence it is necessary to locate a pump station known as the Pittock Pump Station on property presently under control of the Bureau of Parks; that the Superintendent of the Bureau of Parks has approved the construction of the pump station together with attendant facilities for its use; that the pump station will not unduly interfere with the recreational use of the property; now, therefore, authority hereby is granted to the Bureau of Water Works to construct and maintain a pump station together with all necessary utility connections. The location is described as follows:

Begin at an iron pipe at the Southwest corner of Hilltop Addition located in the Southwest Quarter of Section 32, T1N., R1E., W. M.


Thence North  $89^{\circ}42'30''$  East 442.53 feet along the South boundary of Hilltop Addition to a point on the East line of the William Naylor D.L.C.; thence South  $00^{\circ}03'30''$  West a distance of 240 feet along the East boundary of the William Naylor Donation Land Claim line, the true point of beginning; thence from said true point of beginning East a distance of 50 feet; thence North a distance of 30 feet; thence West a distance of 50 feet to the East boundary of said William Naylor Donation Land Claim; thence South  $00^{\circ}03'30''$  West 30 feet along the East boundary of said donation land claim line to the true point of beginning.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of




