ORDINANCE NO. 123207

An Ordinance assigning to the Bureau of Parks certain properties of the City located in the South Auditorium Urban Renewal Project, designating the area in Block A as Pettygrove Park and the area in Block B as Lovejoy Terraces, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that the Portland Development Commission, the agency of the City of Portland for urban renewal, has by resolution turned over to the City certain properties which should be inventoried and assigned to the Bureau of Parks; now, therefore, the following-described City-owned property which has heretofore been administered by the Portland Development Commission, is hereby assigned to the Bureau of Parks and shall be so inventoried by the Property Control Officer, both of which parcels are in the city of Portland, Multnomah County, Oregon, more particularly described as follows:

A parcel of land in Block A, South Auditorium Addition, beginning at a point which is N. 71° 39' 20" E. a distance of 2243.38 feet and S. 69° 08' 00" E. a distance of 242 feet and N. 20° 52' 00" E. a distance of 224 feet from the northwest corner of the Finice Caruthers Donation Land Claim and a Portland Development Commission monument bears S. 20° 52' 00" W. a distance of 224 feet and N. 69° 08' 00" W. a distance of 224 feet and N. 69° 08' 00" W. a distance of 136.85 feet to a point; thence S. 69° 08' 00" E. a distance of 136.85 feet to a point; thence S. 20° 52' 00" W. a distance of 136.85 feet to a point; thence S. 20° 52' 00" W. a distance of 136.85 feet to a point; thence N. 69° 08' 00" W. a distance of 254 feet to the point of beginning.

A parcel of land in Block B, South Auditorium Addition, beginning at a point which is N. 71° 39' 20" E. a distance of 2243.38 feet and S. 20° 52' 00" W. a distance of 80 feet and S. 69° 08' 00" E. a distance of 259 feet and S. 20° 52' 00" W. a distance of 224 feet from the northwest corner of the Finice Caruthers Donation Land Claim and a Portland Development Commission monument bears N. 20° 52' 00" E. a distance of 224 feet and N. 69° 08' 00" W. a distance of 229 feet; thence from said beginning point S. 69° 08' 00" E. a distance of 237 feet to a point; thence S. 20° 52' 00" W. a distance of 137 feet to a point; thence N. 69° 08' 00" W. a distance of 237 feet to a point; thence N. 20° 52' 00" E. a distance of 137 feet to the point of beginning.

ORDINANCE No.

Section 2. The above-described parcel in Block A, South Auditorium Addition, hereby is designated Pettygrove Park, and the parcel in Block B is designated Lovejoy Terraces.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the city of Portland in this: In order that there may be proper recording of the property and its assignment made a matter of record; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
