ORDINANCE No. 123270

An Ordinance authorizing purchase of Lot 87, Blythswood, located in Forest Park at N. W. Belgrave Avenue and N. W. Beatrice Avenue, for the Bureau of Water Works, at a cost of \$200, subject to certain restrictions, authorizing the drawing and delivery of a warrant, and declaring an emergency.


The City of Portland ordains:

Section 1. The Council finds that it is necessary and in the public interest to acquire Lot 87, Blythswood, Multnomah County, Oregon, located in Forest Park at N. W. Belgrave Avenue and N. W. Beatrice Avenue, for use by the Bureau of Water Works; that such property is presently owned by Multnomah County which has offered to sell the property to the city for the sum of \$200 with the restriction that the property be used for the public interest; that such is a fair and reasonable price to be paid and the purchase should be authorized; now, therefore, purchase of Lot 87, Blythswood, Multnomah County, Oregon, from Multnomah County is hereby authorized for the purchase price of \$200, such purchase to be subject to the restriction that the property purchased shall be used for the public interest.


Section 2. The Mayor and Auditor are hereby authorized and directed to draw and deliver a warrant in the sum of \$200 payable to Multnomah County, Oregon, which shall be delivered at such time as the city has received an appropriate form of deed from the county conveying the property described in Section 1 of this ordinance as therein specified, which deed shall be approved as to form by the City Attorney. The warrant shall be charged to the Water Construction Fund, Appropriation Land (5900.780).

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that the property described in Section 1 of this ordinance may be purchased for Water Bureau purposes without unnecessary delay; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
