#### Budget Testimony May 12, 2016

Mayor Hales and Commissioners,

My name is Bill Bagnall and I am speaking on behalf of Friendly Streets, a nonprofit organization focused on livability issues across the City. Thank you for the opportunity to testify today.

There are numerous competing priorities when creating a City budget and it is understandably often difficult to decide which take precedence. I wish to speak in support of several budget items that critically impact livability and quality of life in our communities:

#### ONI

ONI provides essential services relating to outreach, livability and quality of life in our city. We urge you not to make cuts to core programs such as neighborhood grants, graffiti abatement services and the crime prevention specialist position.

We further urge supporting a budget to include the following:

- Retention of one time funded positions for mental health specialists working on the houseless crisis.
- A "New Portlanders" program specialist.
- Office support for noise control and liquor licensing programs.
- Neighborhood and community grants programs including growing the neighborhood grants program, small grants to community organizations of color and youth action grants.
- Accessibility fund to restore the ability of Neighborhood Associations, Diversity and Civic Leadership (DCL) grantees, and ONI programs to overcome barriers to participation by providing support for language interpretation and translation, childcare, transportation and ADA accessibility.
- Staffing additions supporting ONI admin and grants admin, Public Involvement Advisory Council support, Multnomah Youth Commission support, and Crime Prevention admin support.
- Additional funding for District Coalitions, Diversity and Civic Leadership organizations and Resolutions NW to work together to create and implement a robust public involvement effort around the City's Housing State of Emergency and to provide timely information from other involved parties, including the Housing Bureau, Mayor's office and A Home for Everyone.
- Strategic budget planning for one-time process for ONI's Budget Advisory Committee to develop
  a strategic budget plan and strategy for addressing inequities in our civic engagement
  programs.

#### **GRAFFITI INVESTIGATION UNIT**

We have serious concern about the staffing of the Police Bureau's Graffiti Investigation Unit which has recently been totally disbanded.

As a part of the Neighborhood Response Team at Central Precinct, the two-person Graffiti Investigation Unit in the past functioned very effectively in processing graffiti reports City-wide, even when called upon at times to provide support for special events. Graffiti in Portland was kept under relative control, but today has become rampant across all areas of the city.

The job of graffiti investigation is one of a number of essential ingredients to maintaining Portland's quality of life and keeping neighborhoods livable. The failure to properly enforce our graffiti laws encourages an influx of taggers from all over the country and leads to many other insidious activities. The ever increasing deterioration of Portland in this regard is unacceptable. Portland in the past was a progressive national leader in graffiti enforcement along with other quality of life matters. The failure to allocate appropriate resources to livability issues is akin to deferring street maintenance of which we face the consequences today.

As you consider the budget for the next fiscal year, we strongly urge that funds be allocated to restoring the GIU.

Dear Mayor Hales:

The Portland Business Alliance (Alliance) represents nearly 1,900 member businesses in the Portland area; approximately 80 percent of our members are small businesses. The Alliance has long raised the unique negative impact of the Business License Tax (BLT) on businesses, especially small businesses, operating in the city of Portland and Multnomah County. The proposal to increase the city BLT by 14 percent moves in the wrong direction and the Alliance strongly opposes this increase.

Except for Multhomah County, no other jurisdiction in the metro area has anything remotely similar, resulting in higher operating costs to do business in the city and creating a competitive disadvantage for many businesses. The Alliance recently contracted with EcoNW to evaluate the relative cost of doing business in Portland versus other jurisdictions in the metro area. Whether it be manufacturing, wholesale, retail, healthcare and social assistance or computer system design, the costs of doing business in Portland is higher due to the BLT. Further, especially in dealing with hyper-local taxes like the BLT, economic research shows there is a negative impact on employment in areas with a higher local tax burden.

Notwithstanding the above impacts to business operating costs and competitiveness, which alone warrant grave concerns about increasing the BLT, there is no compelling reason to increase this tax in this environment. The city of Portland has a large budget surplus this year, as it did last year, largely due to increased receipts from business taxes. Without any increase, the city's discretionary budget is the largest it has ever been. Ongoing additional revenues are forecast for the future.

Not only is the city's budget higher than it has been, the timing of this proposed increase comes as businesses are trying to absorb previous policy decisions that will increase costs, as well as a plethora of other potential cost increases, including the minimum wage increases, paid sick leave, TriMet payroll tax increase, city gas tax, gross receipts tax, affordable housing bond and a Portland Public Schools bond, to name a few. It seems unwise, to say the least, to further penalize one of the major drivers of this revenue growth to the city when the city's resources are already up significantly.

We do agree that prioritizing housing affordability and homelessness is critical, as well as bolstering the Portland Police Bureau staffing to meet demands throughout the city and investments to ameliorate the continuing degradation of city streets. With additional forecasted resources based on existing sources and an effort at prioritization, this could be accomplished.

However, rather than celebrating the windfall in this year's revenue, the conversation now turns to what should not be funded in the Mayor's proposed budget.

With such a quick turnaround between the release of the budget and scheduled comment, the Alliance has not had an opportunity to review each line item. We urge Council to slow down and work together to develop a budget within existing city resources. We understand Commissioner Novick has already proposed some ideas for cost savings which should be considered. Undoubtedly other commissioner could suggest efficiencies as well.

For example, Commissioner Novick has suggested that the \$1,466,538 designated in the Mayor's budget (but not requested by the Bureau of Transportation) for adding a protected bike lane on Naito Parkway be reallocated. Replacing an auto lane with a bike lane on Naito has not been properly studied and is out of context with the city's plans to undertake a multi-modal plan in downtown. Given important priorities like homelessness and housing, it makes no sense to rush this project forward before its potential impact is known.

The Alliance would have preferred to have a discussion about tax increases before your proposed budget was released, but since that did not happen we submit this letter to register our strong opposition to the proposed change in the BLT and to reiterate that the city could and should develop a plan to live within its means given the protected record revenues.

The intent of this letter is to convey the Powellhurst-Gilbert Neighborhood Association's strong support of the Lents Stabilization and Job Creation Project, and to encourage you to ensure that funding for this innovative project is maintained as you build the coming year's budget.

During our most recent general membership meeting on May 9<sup>th</sup> we had the opportunity to learn more about the Lents Stabilization and Job Creation Project from State Representative Jeff Reardon, Marie Walkiewicz from the Bureau of Environmental Services, Nicole Peirce with the Oregon Department of Transportation, and Andrea Matthiessen from the Bureau of Housing and Community Development. After a forty-five minute presentation and question and answer period our assembled members voted unanimously in favor of the City of Portland providing funding to continue the next steps in this collaborative endeavor.

We were most impressed that various bureaus and individuals are working together to solve complex systemic issues that don't have easy resolution when viewed on their own. This project has the potential to mitigate flooding of Johnson Creek, increase neighborhood stability through the reduction of homeowner flood insurance costs, and create jobs by enhancing industrial site readiness in an area of the city that desperately needs greater employment opportunities. In short, by establishing a floodplain mitigation bank and engaging homeowners through a willing seller program, the project would trade storm water retention in one part of our area for the opportunity to build up the level of land so that light industry would be willing to invest in greater infrastructure near the area of Foster and I-205. Concurrently the project would undertake measures to reduce flood insurance costs through better management of the flooding, offer technical support to homeowners to make their properties more defensible, and ultimately help homeowners in the Lents and Powellhurst-Gilbert neighborhoods from being displaced by rising costs.

We also believe that the whole-systems approach that the Oregon Solutions process is undertaking has the potential to be a model or a blueprint for other projects throughout our region and state. Albert Einstein believed that we can not solve our problems with the same thinking that created them, and our neighborhood association's assembled members believe that this collaborative and integrated approach to solving local issues is on the right track. Please lend your support and funding to the Lents Stabilization and Job Creation Project.

Dear Mayor & Commissioners:

I understand that one of your budget considerations is whether or not to include money in the budget to purchase body cameras for Portland Police Bureau.

I respectfully disagree that this should be a budget priority for this budget cycle. There are many unanswered questions surrounding the purchasing and implementation of this tool. While the state legislature passed base legislation each local policing agency has the ability to improve on the very basic legislation that passed in Salem.

Portland Police Chief Larry O'Dea conducted 3 community meetings last year seeking public input on this important issue. Each step of the way the police bureau has assured the public we were a long way from purchasing these cameras and the public and the police union would have ample opportunity to weigh in on the when, how, who and under what circumstances the public have access to the data are all outstanding questions.

This legislative role can only be address through a public policy deliberation and vote, ultimately by this city council before we invest the huge resources necessary to outfit Portland police with body cameras.

I find it troubling that you are considering false choices in this budget process. Homeless services, housing services and a real analysis of how many services Portland police currently provide that are outside of their lane and areas of expertise.

Until all Portland police officers who are physically able are working rotating shifts on the street and a full accounting of how many police officers do things other than policing has been ascertained I just don't see how you can sell this huge need for incentive pay when its already a living wage employment opportunity. Money is not the reason people don't want to be Portland Police officers. The internal survey conducted by the COCL speaks volume to the needs of the officers on the street yet, that is not reflected in the proposed budget.

My advice is don't by cameras but continue broad outreach on the policy that needs to be approved by the public and needs to be part of the next Portland police association contract negotiations. The contract expires in Jun 2017, so what's the rush?

Dear Mayor and City Commissioners,

My name is Steve Trujillo, I'm the senior pastor of Father's House City Ministries, a church that has served the central city for over a decade, I'm also the director of justice ministries for the Transformation Network, a nonprofit with programs for those who are ho are either the targets of sex traffickers and people experiencing homelessness.

Today I want to remind you that the primary role of government is to insure the safety of the public it serves. For the over 15 years the Portland Police has experienced budget cut after budget cut. It's obvious now that all those cuts have resulted in diminished service by the Bureau to the public. In my community organizing work as a public safety advocate, I am hearing an ever growing frustration with how long it takes to get a response to calls for service, if there is a response at all.

I believe the Bureau is doing its best to serve even though it's been cut to the bone. Well, it's now time to place meat back to the bones of the Bureau. Please approve the add-ons that Mayor has put on the budget for our police and first respondents, we must resource those who put their lives at risk to keep us safe, and to give them more options to innovate in their policing work. Part of that innovation is the ability to divert people from the criminal justice system into a system of accountability, support, and care that will help them move forward, out of addiction, criminality and houselessness.

I came to this city as a child with my family having nothing; we were political and religious refugees fleeing tyranny and oppression. It was the kindness of the people of Portland and innovation of programs available to my family that allowed us to flourish so that now all three of us who grew up in this city live a life of service to others.

Today our city is full of a new kind of refugee, economic refugees; those who have lost it all, who have no place to call home. They are not from other nations but from our city and our nation. They are those who have fallen into cycles of poverty or are under the affliction of abuse, be it from self or others. If these folks are not helped, many could end up in the criminal justice system, costing us much more than diversion. It's time to innovate, time to create more options, more pathways for people to succeed out of poverty, addiction and even criminality.

At some time in the future, all of you will end your time of service to our city. It's up to you what legacy you leave behind. I hope it's a legacy that says; the public safety of all our people was not neglected but enhance during my watch. And the safety net for the vulnerable and those needing help was strengthen, made more equitable and effective. So please, support the Police budget, and support the budget for expanded services for those experiencing homelessness.

I'm Mike Rosen, 6005 SE 20<sup>th</sup> Avenue, Portland, and a member of the Portland Public School Board, but here to speak on my own behalf.

# Proposed Business Tax Increase Concern Statement: Venture Portland Board of Directors May 9, 2016

Venture Portland is the support system for Portland's 50 unique neighborhood business districts. Together, our districts contain 19,200 businesses (98% of which have five or fewer employees) and provide 267,000 jobs. As business owners and business district leaders, we know that, in Portland, SMALL is really BIG. Which is why we are once again highly frustrated by Mayor Hales' decision to announce a business tax increase without contacting us or providing adequate opportunity for our volunteer-run business associations to either take a position or meaningfully participate in the budget process.

As the driving force behind Portland's economy, we know that small businesses create two out of every three new US jobs and locally have provided record-breaking revenue surpluses for the last two years. As committed partners to City Council, we expected to be included in conversations about a tax increase that would have a \$9 million impact on businesses. Following the recession, businesses have been asked to fund new employee benefits (Sick Leave), change hiring processes (Ban the Box, Removing Barriers to Employment), pay more taxes (TriMet Payroll Tax and Gas Tax) and significantly increase employee wages (Statewide Minimum Wage). Adding additional financial burden to small businesses should, at a minimum, require thoughtful public process and a commitment to fiscal responsibility, public safety and the provision of essential City services.

We applaud the proposed Owner's Compensation Deduction increase to \$125,000. Venture Portland has pushed for this increase for almost a decade. We also applaud the Mayor's goals to greatly reduce the lag time between hiring Police Officers and putting them on the street; the 50-officer force deficit and current 2-year hiring process has left our business districts woefully under-served. In addition, the lack of enforcement of the new 'Safe Sleep' policy has made our businesses and business districts vulnerable and greatly reduced the safety and livability of our neighborhoods.

We noted during the extensive debate over the proposed Portland Street Fund that transparency and accountability from our elected officials is critical for earning our trust and support. As City Council continues to work through this rapidly evolving budget process, we strongly encourage Mayor Hales and the other Commissioners to create a budget that adequately funds City priorities and supports neighborhood businesses and business districts.

Dear Portland City Commissioners,

I am writing to you today in support of the Portland Police Bureau's budget request for 2016-2017.

The current staffing crisis facing the Portland Police Bureau should be of grave concern to all of us who live, work and love this incredible city. The livability of this beautiful place is at stake as the number of officers drops, so does our feeling of safety and security.

My biggest concern, however, is for those already underserved and disenfranchised here in Portland. As usual, these are the people who will feel the greatest impact from fewer police officers on the streets. Especially, those citizens dealing with mental health issues. They are already some of the most vulnerable people. They are more likely to be the victim of a violent crime then to inflict one on another, and they are overrepresented among those who are involved in police shootings (with 25% or more of people fatally shot by the police having had some type of mental health issue in the country). Here in Portland, we know that many of calls that Portland Police Officers respond to involve someone with some level of mental illness. Successful - nonfatal - outcomes to these calls require training, time and a great deal of patience.

I ask you to think, seriously, about what happens when Portland does not have enough officers to allow for calls that require time and patience? What happens when officers feel ever increasing pressure to clear calls as quickly as possible, so they can move on to the next? And, think about what happens, not only to the person the officer is trying to work with, how does this situation impact the officers, as well. What happens when Portland's officers are overworked and pressured constantly because they cannot address the calls for service they receive in the way they want to? The unrelenting stress on police officers is already great, think about the impact of fewer officers with ever increasing calls for service. They will be set up to fail in ways that will cost all of us - citizens, officers, families, the community, and the City itself - much more than we should ever contemplate paying - in lives, safety and dollars.

I understand the complexities of creating budgets that try to meet a myriad of needs with a finite resource. It is hard, and causes so many sleepless nights. For me, however, the Police Bureau's budget has to take priority as they are the ones who help make Portland what it is - the most beautiful and one of the safest cities in the country.

Thank you, to each of you, for your service to the people of Portland. And, thank you, for seriously considering the broader, long-term ramifications of not meeting the Portland Police Bureau's budget request. I greatly appreciate it.

Dear City Council,

I will be giving public testimony tomorrow in attempt to get some urgent policy matters involving Last Thursday on Alberta Street put to rest for the year.

My first question will be is registration going to be an enforceable requirement for Last Thursday's 2016 season.

I believe there are liability issues if the City of Portland write themselves an event permit making registration and enforceable requirement without acquiring consent from the private property owners/tenants adjacent to Last Thursday's street closure. In addition, I am compelled as a concerned citizen, to help any event participant acquire legal representation if they get evicted, fined, or arrested for what I believe to be an exercise of their freedom of speech.

Last year, the City of Portland collected people's personal information off of the presumption that registration is going to be a requirement this year.

My second question will be what precisely the City of Portland has in mind when they say, "we are looking for an organization to take over management of the event."

Last year, Artists United received 56 endorsements from businesses inside Last Thursday's street closure. We offered to progressively pay for the public safety expenses starting with portable restrooms in September, and offered to acquire \$50,000 in event sponsorship contracts for this year's Last Thursday event series. The City of Portland said what we were doing didn't matter, wouldn't accept \$50,000 and refused to set any goals or requirements for an organization to take over management of Last Thursday.

I'm still working on a plan that every stakeholder can get behind. It's being piloted in Southeast on their monthly art event, First Friday. Everything is going great, and I think the next mayoral administration and the community of Alberta will be happy with our test results.

If registration is not going to be an enforceable requirement at Last Thursday's 2016 season, I believe it's

necessary you tell everyone it's voluntary. You should also admit you made a mistake by thinking it was going to be a requirement this year.

I hope we can put these urgent issues to bed during my testimony so we all can enjoy our summer without worrying about what's going to happen at Last Thursday this year.

I would appreciate a more in depth response than I was given in my previous testimony.

Kris Hudson Budget that will inappropriately reduce the number of audits it can conduct each year. Auditing city bureaus is vital to identifying improvements that can increase effectiveness and efficiency as well as address inappropriate or unclear governmental practices. Since audits frequently identify opportunities for financial

savings and enhanced public services, we recommend allocation of the resources needed to maintain the same number of audits in the upcoming year.

The League is a long-time observer of the Independent Police Review (IPR) Division's Citizen Review Committee. Along with the U.S. Department of Justice and many in the community, we have urged the IPR to conduct more independent investigations of police misconduct rather than relying in the Police Bureau to do the job. We are pleased to see that the proposed budget includes funding sufficient to add two more IPR investigators.

On the other hand, the impasse over how to fund the independent and impartial Hearings Office is of great concern. The office is the place individuals go to exercise their rights by appealing city decisions. It is one way the public can hold the city accountable. The League, along with City Council, supported recent improvements that removed barriers to accessing the hearings process. We do not want to see the Hearings Office have to find another home. The most logical place

for this function is in the Auditor's office. Furthermore, the Auditor does not believe the proposed cost recovery model will provide a stable source of revenue and the administrative burden to implement that model is excessive in light of the fact that there are only 3.5 FTE in the Hearings Office.

We urge you to take the Auditor's concerns into account and provide sufficient general fund dollars to cover the cost of keeping the city accountable to the people it serves. Indeed, rather than proposing inappropriate budget cuts, the Auditor should have in her budget the additional resources needed to hire a staff attorney and add policy staff capacity. City Councilors have numerous policy staff members who provide the support they need to carry out their duties and explore new initiatives. In contrast, the Auditor only has the people who carry out the work within her office to assist her with those efforts. Furthermore, independent legal counsel is needed because of the inherent conflict between protecting the city from exposure to risk and holding it accountable.

The Auditor's independence is an important and essential feature of Portland's city government and the office should have the resources it needs to insure accountability and transparency.

I have questions regarding Monday, May 2<sup>nd</sup> budget conference. Why were we, **Police Record Specialists**, not mentioned or included at the conference when one of your staff advised us we would be? Are **Police Records Specialist** in your budget for an increase in wages?

It has been documented for some time that the **Police Records Specialist** job is underpaid. We are the biggest Police Records agency in Oregon yet the least paid. We have a huge problem with retention and not enough people to do the job. In 1982, Police Records had *around* 80 people. We now have *approximately* 54 Police Records Specialists. Crime has increased and amount of officers hired has increased but Records employees have been diminishing. **Police Records Specialist** are support staff for our police officers. Our work load has only increased but the number of people has decreased sufficiently. Records has an all-time high back log and complaints are many. This back-log has been due to high employee turnover rate, new records management systems and other issues within the division. The work of **Police Records Specialists** does have an impact upon the community.

We have asked for more money and help to retain employees, but the Mayor and council now sends the message they don't want to even listen to us? It is very dis-heartening that once again the Mayor and his council people pay no attention.

Yes, I am aware we are currently in process of interviewing for Police Records Specialists and a Public Records Unit within Records has been approved to higher one extra person. While this is all appreciated, it still doesn't help the problem of retention and equal pay.
