ORDINANCE NO. 128737

An Ordinance vacating all that portion of S.W. Mill Street lying between S.W. 10th Avenue and S.W. 11th Avenue, and also all that portion of S.W. Montgomery Street lying between S.W. 10th Avenue and S.W. 11th Avenue, under certain conditions,

The City of Portland ordains:

Section 1. The Council finds that by Resolution No. 30435, adopted by the Council January 9, 1969, proceedings were initiated for the vacation of all that portion of S.W. Mill Street lying between S.W. 10th Avenue and S.W. llth Avenue, and also all that portion of S.W. Montgomery Street lying between S.W. 10th Avenue and S.W. 11th Avenue, hereinafter more particularly described; that the purpose of said vacation is to provide area for building construction for Portland State University; that pursuant to ORS 271.130 the Council fixed a time and place for public hearing before the Council, 9:30 A.M., February 26, 1969, in the Council Chambers of the City Hall, in the City of Portland; that the City Auditor published notice of such hearing in the city official newspaper, namely Daily Journal of Commerce, once each week for four consecutive weeks, and posted such notice in certain places in area proposed to be vacated, all in accordance with provisions of ORS 271.110; that said matter came on regularly for hearing and no objections were made or filed thereto and it is in the public interest that said streets be vacated; that said vacation will not interfere with any improvement proposed by the Commission of Public Docks nor with reasonable access to the water front or transportation terminal, as evidenced by letters of consent from both the Port of Portland and the Dock Commission, made a part of Council Calendar No. 778 (1969); now, therefore, the following described property hereby is vacated upon the following conditions;

> All that portion of S.W. Mill Street lying between S.W. 10th Avenue and S.W. 11th Avenue, also all that portion of S.W. Montgomery Street lying between S.W. 10th Avenue and S.W. 11th Avenue, in the City of Portland, County of Multnomah, State of Oregon.

(a) That Portland Development Commission make all necessary arrangements for paying the costs of abandonment of an existing 2-inch diameter water main in S.W. Mill Street and for transferring the water service to 1176 S.W. Mill Street to a new location in S.W. 11th Avenue, all as required by the Chi f Engineer, Bureau of Water Works. (b) That Portland Development Commission make all necessary arrangements for payment of costs of reconstructing and closing the intersections of S.W. Mill and S.W. Montgomery Streets with S.W. 10th Avenue and S.W. 11th Avenue as required by the City Engineer.

(c) Nothing herein contained shall cause or require the removal or abandonment of any sewer, water or gas main, conduit of any kind, wire, pole or thing used or intended to be used, for any public service, and the right hereby is reserved for the owner of any such utility or thing to maintain, continue, repair, reconstruct, renew, replace, rebuild, and/or enlarge any and all such things, with the exception of a 2-inch diameter water main in S.W. Mill Street for which no easement shall be reserved, and also subject to the condition and understanding that the easements herein reserved to the City for maintenance of existing sewers are of a temporary nature and at such time as street areas, in which the extensions of said existing sewers are vacated and utilized by the University, or when the City engineer finds it in the best interest of the City to abandon said sewers Portland State University agrees to accept the responsibility of maintaining the sewers as abandoned; that no building or structure of any kind shall be built or erected within a distance of ten feet from the center line of any such utility, except upon the written consent of the City Engineer and the owner of the utility, and any and all contemplated building plans in said vacated area shall be submitted for approval to the City Engineer and to the Director of the Bureau of Buildings, to the end that such construction may be so adjusted with reference to all public utilities in said area as to cause a minimum of danger or inconvenience to the public and to the owner of such utility and to protect and preserve the same as presently constructed or hereafter reconstructed, renewed, replaced and/or enlarged.

Section 2. Portland State University and Portland Development Commission shall file with the City Auditor in form approved by the City Attorney a document in writing accepting the terms and conditions of this ordinance.

Section 3. The City Auditor shall at the expense of Portland State University and Portland Development Commission
