ORDINANCE No. 1:30418

An Ordinance accepting a bill of sale from the Port of Portland and Fire District No. 26 for the 24" water main, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that by agreement and in accordance with the provisions of the Administrative Review Report of March 12, 1968, adopted by the City Council March 14, 1968, Council Calendar No. 1062, the Fire District No. 26 and The Fort of Portland were to transfer title to the 24" water main from the north City of Portland boundary a distance northerly of some 8,540 feet, including valves and hydrants to the City of Portland along with private easements, in consideration for which the City agreed to assume maintenance for said main and appurtenances, all lying in Phase I of the Rivergate Industrial District project and in Fire District No. 26; that the Port of Portland and Fire District No. 26 have row submitted a bill of sale for said equipment, and the bill of sale should be accepted; that by letter dated February 3, 1970 from the Superintendent Bureau of Water Works, it is recommended that said bill of sale be accepted from the Port of Portland and Fire District No. 26, and refers to Drawing No. RG-63-505, 1 through 4, dated August 7, 1969, which recommendation has been approved by the Commissioner in charge; now, therefore, the bill of sale covering the 24 inch water line located in accordance with John W Cunningham Associates plans (as built, 8/7/69) bearing Nos RG-68-505. 1 through 4, hereby is accepted from The Port of Portland and Fire District No. 26

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that there may be no delay in meeting the obligations of the City; therefore an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
