Reappointment to River Community Advisory Committee (RCAC) Subject:

The River Community Advisory Committee is a citizen advisory body, composed of six members who represent a variety of floating structures interests. Members are appointed by the Commissioner-in-charge of BDS and confirmed by the City Council for three-year terms and will serve no more than two complete three-year terms, unless the Director recommends approval of a longer term and the Mayor and City Council approve the extended appointment, as specified in Portland City Code Title 28.

I am recommending Samuel Galbreath for a second, 3-year term from June 22, 2016 to expire on June 21, 2019. Sam served on the BDS River Community Advisory Committee for a partial term from January 5, 2011 through October 31, 2011 and a first full, 3-year term from November 1, 2011 through October 31, 2014. He also has extensive experience as a floating home resident and active participation in local and regional community and floating home development boards, forums, and quality control efforts.
