There are a few items that we wanted to bring to your attention:

Expanded Transportation System Plan (TSP) Classification Maps

Commissioner Smith asked staff to prepare maps that show the proposed transportation system for each mode within the Central City and how it connects to the system just outside of the Central City boundaries. The attached maps were created by PBOT to meet this request.

Please note that while the proposals inside the Central City boundary are all being processed through this project, the transportation system outside this boundary is being updated through multiple projects at different stages of public review as outlined below:

- Bicycle and Design classifications are part of the TSP Update Stage 2, which will be before City Council in Fall 2016.
- Pedestrian, Freight, Transit, Traffic classifications are from the 2007 TSP and will be revised in the upcoming TSP Update Stage 3.
- Emergency Route classifications are a working draft of the upcoming TSP Update Stage 3.

Discrepancies between Transportation Studies, Projects and Actions

Staff identified discrepancies between the Transportation System Plan (TSP) candidate studies and projects listed in Volume 2B and the work plan for PBOT staff shown in the Volume 5 Action Table and expanded upon in the section following the table. These lists should be the same. Staff plan to reconcile them and bring a proposed set of amendments to you for your September 27 work session.

Disclosures (Amendment to Volume 6)

In the summer of 2015, the City Ombudsman received an anonymous complaint from a group of concerned citizens. They claimed that certain members of the West Quadrant SAC had conflicts of interest that weren't disclosed in the course of the committee's work — and should have been. The Ombudsman analyzed the case and determined that it appeared likely that multiple SAC members should have - but did not - publicly disclose potential conflicts of interest before discussing and voting on recommendations for the West Quadrant Plan. Because her opinion was after the fact, as a remedy, she recommended that BPS call for West Quadrant SAC members to publicly disclose any potential conflicts of interest before the Planning and Sustainability Commission or the City Council hold hearings on and adopt the final plan.

The Ombudsman also recommended that BPS compile a disclosure document that itemizes the responses and should note if any members fail to respond. That document should be entered into the public record and presented to the decision-makers. This information can be found in Volume 6 starting on page 31.

At the July 26 hearing, Nolan Leinhart submitted a letter into the record related to the disclosure request. Here is a summary of the SAC members who did not submit disclosure forms including an updated listing for Nolan Leinhart.
