ORDINANCE NO. 187911

* Authorize an Intergovernmental Agreement with Multnomah County to provide \$96,999 in grant resources for a feasibility analysis on potential Pay for Success funding models to support the connection between affordable housing interventions and improved health outcomes for low-income households (Ordinance)

The City of Portland ordains:

Section 1. The Council finds that:

- 1. The Portland Housing Bureau successfully applied to the University of Utah for a grant in the amount of \$96,999 to conduct a feasibility analysis around Pay for Success models of funding to support housing interventions that successfully provide long term health benefits for low-income communities.
- 2. The Portland Housing Bureau and the Multnomah County Health Department have been frequent partners on the implementation of programs that address housing condition in order to improve health outcomes around lead poisoning, asthma, indoor trip and fall hazards and other environmental health conditions.
- 3. The Multnomah County Health Department has done previous work around Medicaid cost reimbursement for asthma prevention and is currently involved in conversations around Pay for Success partnerships in Oregon and is well positioned to engage stakeholders in conversations around data driven health outcomes for housing programs.
- 4. Portland now desires to enter into an agreement with Multnomah County to undertake a feasibility analysis to explore the possibility of future Pay for Success funding models to increase the local capacity to provide home repair, weatherization, lead hazard reduction, and other housing intervention strategies as further described in Exhibit A.
- 5. Funding has been appropriated in the FY 16-17 Adopted Budget in the amount of \$96,999.

NOW THEREFORE, the Council directs that:

- a. The Bureau Director or designee is authorized to execute agreements in a form similar to the Agreement attached as Exhibit A.
- b. The Mayor and Auditor are hereby authorized to make payments on these contracts from the PHB federal grants fund budget.

Section 2. The Council declares that an emergency exists because the grant funds must be contracted within the required timeframes; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
