

Scrape and seal all fire/smoke damaged members not removed by demolition. Replace or double from bearing to bearing 4-6 2X4 roof rafters and 2-4 2X4 ceiling joists over bathroom and bedroom at rear wall as needed where char exceeds 1/4" or cut by firefighters. Provide fire blocking per code in all opened wall areas. Remove all smoke damaged insulation and replace with wall insulation to be R-15, attic R38. Windows to be CL65, doors CL54. Provide smoke detectors to code. Electrical for 2-4 fire damaged circuits. Repair damaged electrical branch circuits, including treatment of knob and tube wiring per amended Article 394 of 2005 NEC. ## Permit Revision Submittal Requirements and Application

A Permit Revision is required when there are proposed changes to the project after the permit has been issued. This may arise due to discrepancies between the city-approved permit drawings and actual field conditions, or the customer has changed their mind about an aspect of the project. In all cases, a revision to the existing permit must be submitted, reviewed and approved.

### Applicants will provide:

A copy of this application

Three (3) sets of plans that clearly reflect the proposed change(s).

Drawings and calculations must be stamped and signed by the Architect and/or the Engineer of Record, if applicable.

One (1) copy of the original city approved permit drawings. (NOTE: If your project has an assigned process manager please contact them regarding submittal of the revision).

Two (2) sets of calculations, if applicable

Inspector's correction notice, if revision is due to an inspection correction

Revision fee (paid at time of submittal)
