ORDINANCE NO. 111819

An Ordinance authorizing the acceptance of two deeds from Walter H. Stephenson and Sara Alice Stephenson, authorizing execution and delivery of a deed to Walter H. Stephenson and Sara Alice Stephenson, authorizing payment for title reports not to exceed \$67.50, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1.
